QUICK REVIEW OF 2014-2015

IIWR-MB has continued in it's mission of education, awareness and advocacy for women's human rights, with the involvement of many who support the outreach efforts, and are passionate about making a difference in women's lives.

We have held a number of informative programs, many in collaboration with others, such as:

- On Monday, February 10th, 2014, we heard from Diane Redsky. Diane was the Executive Director of the National Task Force on Trafficking of Women and Girls in Canada. Diane reviewed the work of the National Task Force, and current research that has been done. Forced Prostitution is Trafficking. Canada does have laws it is a crime. Trafficking does happen not just across borders, but within Canada. Statistics show Aboriginal women are highly represented. There is a mistrust and cynicism about interacting with police. The Task Force has just completed consultations in 9 cities.
- On February 24th, 2014, IIWR-MB sponsored What the Niqab Bans Tell Us About Sex and Secularism, with Dr. Jennifer Selby, Memorial University. Co sponsored with the Institute for International Women's Rights Global College and the Department of Religion and Culture, University of Winnipeg.
- On April 10th, 2014, IIWR-MB had Shannon Sampert present on the Topic: "Up Close and A Little too Personal? Media Coverage of Women Politicians" at our general meeting, along with Madilyne Kevany, who told us about the 2014 Meetings of the Commission on the Status of Women, in New York.
- On Thursday, November 20th, 2014, the Voice of Women of Peace, and the Institute for International Women's Right Manitoba sponsored a program titled "Why Girls Matter Stories from Nigeria". It was well supported by the community, with a good turn out We heard from three presenters, all who have either lived or spent time in Nigeria Badriyya Yusuf, who has an MA Indigenous Development Practice; Dr. Grace Kyoon-Achan, who has a Ph.D. in Peace and Conflict Studies, and Florence Okwudili with a B.A. International Development Studies, Post Graduate Diploma in Public Policy and Administration.
- On November 26, 2014, IIWR-MB and IIWR Global College co sponsored a special presentation during the 16 Days of Activism Against Gender Based Violence— "From Peace in the World to Peace in the Home". Moderator: Marilou McPhedran with Presenter: Darcia Senft on the Charter of Compassion and the Compassionate Games, and Ellen Judd who spoke on the costs of Militarism, and Roxana Obasi, who spoke about the harmful effects of FGM and Gertrude Hambira, who shared her personal story of being a human rights defender.
- On March 4, 2015, IIWR-MB and IIWR- Global College hosted a panel at the University of Winnipeg on issues affecting children in care in Manitoba. Moderated and organized by Hilary Taylor, we all learned from the the excellent presentations. Approximately 80 people attended and learned from, listened and asked questions to our exceptional panelists, who shared their various experiences and expertise: A huge thank you to the panelists for donating your time and being so forthcoming with your stories.
- On April 27th, 2015, From the Global to the Local: Sharing Global Experiences. We heard interesting stories from Angeline Rivard and Emily Epp who have just returned from Israel and Palestine. Also the delegation of young members of the Provincial Council of Women of Manitoba who attended the 59th meeting of the Commission of the Status of Women in New York at the United Nations presented on sessions they attended. Inspiring to listen to the stories about their experiences.
- On June 13, 2014 and June 14, 2015 IIWR-MB joined Project Peacemakers and other community organizations to walk for Peace, and to call attention to the devastating effects of war on women and children and the important and necessary work to be done for Peace.
- On June 23rd, Alexandra Shkandrij moderated a well attended panel "Ukraine: Euromaidan and Beyond", with speakers presenting on the current conflict from the Euromaidan revolution to the ongoing crisis, and the role of women in both. Myroslav Shkandrij, Oksana Dudko, Natalia Kuchmenko and Miroslava Pidhirnyj gave background and insights to the current situation that all appreciated.

ADVOCACY REPORT

Prepared for the Annual General Meeting of the IIWR-MB taking place on September 30, 2015

About the Advocacy Committee

The Advocacy Committee was formed in October 2013 and currently consists of 14 members, including:

The role of the Advocacy Committee (the "Committee") is to review various petitions, sign-on letters, commentary, and potential pieces of legislation respecting women's rights issues both locally and globally. The Committee reviews each initiative and advises the IIWR-MB board as to whether or not it would recommend the IIWR-MB sign on as a supporter, create its own letter, or host a discussion on the topic.

Advocacy Committee Operating Procedures

In late 2014, the Committee created operating procedures to ensure the consistent, transparent, and effective functioning of the Committee's decision-making. The new operating procedures identify a minimum quorum required in order to make a recommendation to the Board regarding a specific action item. Additionally, as opposed to a simple majority rule, the operating procedures require a minimum number of favourable responses in order to positively recommend action. However, where there is significant dissenting opinion within the Committee, or the Committee is otherwise unable to come to a clear and obvious agreement, that is taken as a sign that the action item ought not to be recommended and other alternatives will be discussed (for example, the Committee may create its own letter as opposed to simply signing on to an other's).

The next step with respect to improving the Committee's internal functioning is to create a Committee Mandate to assist in providing clarity around the goals of the Committee.

The Year in Review

Since the 2013 Annual General Meeting, which took place on October 8, 2014, the Committee has considered the below advocacy initiatives on behalf of the IIWR-MB.

We have recommended the IIWR-MB's support and/or participated in the following areas:

- Signed onto the Commission on the Status of Women (the "CSW") and Equality Now's joint statement regarding maintaining focus on gender equality, removing sex discriminatory laws, etc. post -2015;
- Signed onto a call urging the CSW at its 59th session to review and appraise the results of MDGS from Beijing and include more focus post-2015 on 3 areas: (i) Macroeconomic policy; (ii) women's

- work; and (iii) gender-based violence and militarism;
- Joined as a supporter of the Feminist Alliance for International Action's Solidarity Network;
- Participated in a survey created by the Global Network of Women Peacebuilders, ICAN, Cordaid, and the NGO Working Group on Women, Peace and Security. The survey sought to obtain a range of inputs from states, regional organizations, UN entities and civil society organizations with respect to the implementation of resolution 1325, highlighting good practice examples, implementation gaps and challenges, as well as emerging trends and priorities for action in preparation for the High Level Review being conducted by the Security Council;
- Signed onto a recommendation that the Post-2015 Women's Coalition Vision Statement be used throughout post-2015 inter-governmental negotiations and as a possible feminist alternative approach towards the adoption of the sustainable development agenda and its implementation beyond 2015;
- Signed on to a letter prepared by WSPN-Canada urging the Minister of Foreign Affairs to give priority to Canadian compliance with UN Security Council Resolutions on Women, Peace, and Security, especially 1325. Further, the Committee recommended some amendments to the letter with respect to our concern regarding increased militarism as opposed to peacekeeping initiatives;
- Endorsed a blueprint for Canada's National Action Plan on Violence Against Women and Girls prepared by the Up for Debate Coalition as starting point for discussions;
- Recommended additions to the Declaration to be signed at the CSW meeting: (i) include language around unique challenges Indigenous women face; (ii) reiterate call for full reproductive rights for women;
- Recommended that IIWR-MB apply for ECOSOC status;
- Signed on as an organizational supporter to the Campaign for National Medical Drug Coverage.

We have also written our own letters (or assisted in the preparation of letters) in the following areas:

- Wrote a letter to the Republic of Turkey, the UN Secretary General, and the Canadian Minister of Foreign Affairs urging them to stand against demands for a buffer/security zone between Turkey and Syria;
- Assisted in the writing of a letter to the MP for Citizenship and Immigration Canada, highlighting the current problems with immigration and refugee policies, specifically with respect to their impact on women and children.

Looking Forward to New Challenges

In 2015-2016, the Committee hopes to consider partnering with other advocacy groups in an effort to combine efforts and voices.

 Global Citizenship Scholarships at the University of Winnipeg; the Stephen Lewis
 Foundation (Grands n More). We hope to begin work on a Local to Global 2016
 soon—so stay tuned!
- International Women's Day—March 8th, 2015 We sent approximately \$2,250.00 Canadian to support Panzi Hospital and Dr. Mudkwege in the Democratic Republic of the Congo. Raising Our Voices: Celebrating International Women's Day celebrated the contributions of women around the world, in an evening of fun and entertainment. Thanks to all who performed, who came out, who had display tables, and donated to a worthwhile cause.
- We applied for ECOSOC (Economic and Social Council) status at the United Nations.
 This would give IIWR-MB special recognition when participating and advocating for women's human rights.

Co Chair, Nadia Kidwai organized 2 Conversation Cafes:

- December 9, 2014 "Sexual Violence:Power and Silence". With 20 people in attendance, from a diverse range of ages, cultures and professional backgrounds, a lively and informative discussion was held using the "Conversation Cafe" format of intermixing of small groups.
- March 16, 2015: Conversation Café on "Missing and Murdered Indigenous Women and Girls". With individuals from different communities and backgrounds, we discussed ways of supporting action to end the violence against Indigenous Women and Girls.

FROM IIWR-MB ORGANIZATION MEMBERS

MONDETTA CHARITY FOUNDATION (MCF) is pleased to be an organizational member of IIWR. In the early 1970s, two families left East Africa as both immigrants and refugees. Settling in Winnipeg, Manitoba, members of these two families forged friendships, and founded Mondetta Clothing Company in 1986. Nearly 20 years later, Mondetta decided to create a foundation to give back to their original homelands of Kenya and Uganda. MCF was formed in 2004 and acquired charitable status in 2006. Mondetta Charity Foundation (MCF) strives to relieve suffering and reduce poverty in East Africa through

the provision of health, nutrition and education initiatives in partnership with local organizations.

MCF works with Kamwokya Primary School, located in a sprawling urban slum in Kampala, Uganda. Since 2005, MCF has maintained a feeding program that provides a hot and nutritious meal to the school's 1,700+ students on a daily basis, and has served nearly 3 million meals to date! MCF also supports the New Life Home Trust Day Centre in Madogo, a small settlement located in northeastern Kenya. The centre provides educational lessons and daily meals, and is a safe and welcoming space for the 60 vulnerable children that attend. An engaging community outreach initiative for adults is also carried out by this centre.

As the student body at Kamwokya Primary School has greatly increased, the classes have become very crowded. Some classes hold up to 200 students, which leaves many students without a seat. With support from Kampala Capital City Authority, MCF has recently completed the construction of a new three-storey classroom wing at this school, which will greatly reduce over-crowding, and allow more students to attend. Over the next year, we plan to continue advocating for the right to education through our The Other75 campaign. Recognizing that 75% of children that begin Primary School in

Uganda do not complete it, we seek to raise awareness about this issue and utilize our sponsorship program to combat this statistic. We are also in the beginning stages of a water harvesting and filtration project that will collect and purify rainwater, greatly reducing the cost of water for the school, as well as providing a source of clean water to the surrounding community.

(MMVI)</u> - Prior to the inaugural AGA on May 23, 2015 the interim Board and Grandmothers Advisory Council did an incredible amount of work to first establish MMVI and then to secure the title of Provincial Territorial Member Associate of the Native Women's Association of Canada (NWAC).

Those initial steps leading to establishing a physical office space and secure funding for the advocacy work ahead has been the beginning of a journey that will lead indigenous Women of Manitoba to secure stronger places of leadership. In the coming year as we gain greater capacity we expect to continue reaching the goals in our mandate: "To build a strong connection among Indigenous women, organizations and allies across Manitoba supporting a collaborative voice in support of each other while also delivering responsive, effective, and valued research, education, access to resource sharing, and advocacy at the local, provincial, national and international levels."

ACTIVITIES AND ACCOMPLISHMENTS

- May 23, 2015 MMVI held first ever election, the inaugural board is working on the establishment of committees to address three primary areas; Indigenous Women's Leadership; Issues arising from Child Welfare and the broad issues of Murdered and Missing Indigenous Women and Girls.
- Participated in over 50 community events and met with organizations profiling MMVI, creating networks and initiated relationships to consider future partnerships in issues affecting indigenous women in Manitoba.
- Completed a Leadership Guidebook, currently working on implementation and promotion plan for delivery to Indigenous women's groups across the province.
- Information/advocacy supports extended by MMVI office staff during this reporting period:
 - o Child welfare information/supports
 - o Training and employment information
- Winnipeg/urban locations, Northern communities & Reservations
 - o Volunteer requests
 - o Support services for Health related issues
- Dealing with trauma/IRS, Addictions, Depression/suicide, Sexual exploitation, Homelessness
 o Political advocacy
 - o Issues affecting murdered and missing indigenous women and girls
- Family participation in political meetings, Supports for memorial recognition (Family feasts, Spiritual supports i.e. headstone, counselling, Elder/Traditional, Public Events.
