#### **QUICK REVIEW OF 2015-2016**

IIWR-MB has continued in it's mission of education, awareness and advocacy for women's human rights, with the involvement of many who support the outreach efforts, and are passionate about making a difference in women's lives.

We have held a number of informative programs, many in collaboration with others, such as:

- November 19th, IIWR-MB supported and attended a community debrief by Law Students from Manitoba who attended the Indigenous Bar Association meetings in Toronto. We brought refreshments to the Indian and Metis Friendship Center, and supported the students learning and participating, with discussion and dialogue on reconciliation.
- During the 16 Days of Activism Against Gender Based Violence (between November 25th and December 10th, 2015), we promoted the many community events, circulating a calendar, prepared by IIWR-MB, and attending and volunteering at the events. We also sponsored an event on December 2nd, Women Working for Peace in a State of War. Approximately 50 people joined IIWR-MB and IIWR Global College. The evening was informative and the panelists shared stories that inspired the audience to do more to work for peace in the world. Many participants brought articles of outdoor clothing for the Syrian Refugees, and were donated to the Canadian Muslim Women's Association. Financial Donations were made, and Laila and Farouk Chebib facilitated the donations to the Manitoba Muslim Association to help the Syrian Refugees. Panelists included Mais Al Selah, Sandy Deng and Ellen Judd. At the end of the program, everyone filled in a sign to commit to what they would do.



• IIWR-MB held a program during International Development Week. For 26 years, International Development Week (IDW) has taken place during the first full week of February, and is a great opportunity to explore how Canada and Canadians are making a difference around the world! The theme for IDW 2016 was "We Are Making A Difference." As part of IDW, IIWR-MB held a special presentation on February 11th, Voices From the Field – Winnipeggers are making a difference! We heard from our members as they shared their stories of what they have learned in travels, work and study about the lives of women.



April 27th, 2016 Local to Global 2016 – Age of Reconciliation: Restoring the Roles Women Traditionally Play – with Ellen Gabriel. This was the signature event of IIWR-MB, and we raised \$18,000 for 3 organizations: The MATCH International Women's Fund; the Mohawk Language Custodian Association; and Global Citizenship Scholarships for students studying women's human rights at the University of Winnipeg. IIWR-Manitoba was pleased to bring Ellen Gabriel to Winnipeg to speak to a packed venue at the Viscount Gort Hotel. Ellen spoke for over 50 minutes on the topic of reconciliation and restoring the traditional roles of women. She talked about the impact of colonization, residential schools, loss of language, the effects of which we see today. It was an educational and thought provoking evening, that also included a spoken word performance by Mary Black—Quiet—and beautiful singing by Dawn Lavant. Tina Keeper was the wonderful emcee. IIWR-MB thank the many who worked to make this evening such a success, and the many supporters who came out.



On Tuesday, June 14th, a group from the community heard presentations about the experiences of delegates attending the 60th meeting of the Commission on the Status of Women, in the lovely Round Room at Ma Mawi. A group from Manitoba, delegates of the National Council of Women of Canada presented on "Lessons from the Heart – Indigenous Women Bringing Our Children Home". It was a dynamite presentation, with the consequences of Residential Schools being felt strongly today. Manitoba has the highest percentage of indigenous children in care in Canada. We also heard about the actions being taken, and in particular the work at Ma Mawi, and Nelson House, where extended family care is practiced and supported. We also heard from students from University of Winnipeg Global College, who traveled to New York with Prof. Marilou McPhedran to participate in the UN CSW sessions, as delegates of the World Federalist Movement. We heard from Katrina Leclerc and Breanne Lavalee-Heckert who were members of the YOUTH SPEAK OUT panel co-hosted by the Global Network of Women Peacebuilders, Taking IT Global, and Canadian Voice of Women for Peace. The students reported on how much they learned about how the UN system works, and how important it is for young women to be there.

Throughout the year, the Committee reviews various external requests for support respecting local and global women's rights issues and makes recommendations to the IIWR-MB board. The Committee also considers whether to participate with its own advocacy initiatives and in this regard, members of the Committee may conduct research or assist with drafting petitions, letters of support and/or opinion pieces.

#### The Year in Review

Alyssa Mariani

Since the 2015 Annual General Meeting, the Committee has participated in the following advocacy initiatives on behalf of the IIWR-MB:

- Wrote a letter to the political party leaders during the Canadian federal election expressing concern
  on two major issues: (i) the Canada Revenue Agency's special political-activity audits, which effectively silences advocacy groups, and the recent internal government report on the status of women
  in Canada, which pointed out that Canada is falling behind the rest of the developed world with respect to women's equality
- Wrote an editorial article to the Winnipeg Free Press regarding the 16 Days of Violence Against
   Women and specifically, its theme for 2015: women's and girls' right to education
- Signed onto a petition urging the Mount Allison University in Sackville, New Brunswick to reverse its decision to cut funding to its Women and Gender Studies Program
- Supported an open letter addressed to President Kabila and United Nations Secretary-General Ban Ki-moon urging an end to the violence in the Democratic Republic of the Congo

#### From the IIWR-MB Organization Members

#### YMCA-YWCA Winnipeg

The YMCA-YWCA of Winnipeg will host our annual Power of Being a Girl Conference on October 25th at MTYP. This event targets young women of ages 12-14 who have had limited opportunity to engage in community activities and would benefit from a day of inspiring speakers, workshops, healthy lunch, physical activity, and an opportunity to meet other girls from within their division. This year's keynote is Lindy Norris.

The Strong Girl Strong World Committee is comprised of teen girls who may be from a marginalized socio-economical background, may not be previously engaged at school or afterschool programs, and therefore miss many opportunities to participate that could further their academic or professional development. They continue to—learn how to build a strong campaign surrounding their learning about consent, and how to utilize resources in order to self-advocate. The Winnipeg group participated in Pride events, held a launch of their proposed teaching tool at the University of Winnipeg and recently shared their learning with the general public by hosting an information table at Polo Park Shopping Center.

Our childcare portfolio welcomed 4 new school age child care centers this past fall increasing our complement of programs to 33 SACC programs and 4 preschool programs in and around the City of Winnipeg. Up next is the 2017 opening of the 100 space Great West Life infant/preschool program which the YMCA-YWCA of Winnipeg will operate as the Provider of Choice. The opening of this program will increase the Y's offering to over 1700 spaces. We continue to look for innovative opportunities to support families in need of care.

#### Ma Mawi Wi Chi Itata

Ma Mawi Wi Chi Itata **is** a grandmother in the Winnipeg family of community service providers. She was established in 1984 to reclaim Indigenous people's inherent role and responsibility as the caregivers for Indigenous children and families in Winnipeg. We are a community mandated, Indigenous directed and supported human service organization, delivering children in care and community based programs and services to Indigenous families. The name Ma Mawi Wi Chi Itata translates from Ojibway into the phrase "we all work together to help one another" and our programs and services are developed and operate within a philosophy that is embodied in our name. These words reflect a vision of collective responsibility and reciprocity that drives our leadership in Indigenous community based care in Winnipeg.

#### Manitoba Moon Voices, Inc.



In the coming year as we gain greater capacity we will continue to reach the goals in our mission: "To build a strong connection among Indigenous women, organizations and allies across Manitoba supporting a collaborative voice in support of each other while also delivering responsive, effective, and valued research, education, access to resource sharing, and advocacy at the local, provincial, national and international levels."

#### 1. Governance and Administration

- May 23, 2015 MMVI held its first Annual General Assembly, electing a 7 member Board of Directors.
- A 3 year (2016 2019) Strategic Plan was developed and shared with membership at the 2<sup>nd</sup> Annual General Assembly held in June 2016. The priorities identified reflect the important issues, opportunities and key focus areas, that when addressed will allow the organization to flourish.
- From 2016 2019 MMVI will strategically focus efforts around the following priorities: Indigenous Women's Leadership; Issues arising from Child Welfare and the issues of Murdered and Missing Indigenous Women and Girls.
- Completed implementation of promotional plan for membership recruitment. Membership recruitment efforts to date **343 verified memberships as of March 31, 2016**
- Hired Executive Director, and ASETS program Coordinator

#### 2. Communications and Programming

- Launched Website and Facebook page. Continued development and expansion of communications strategy.
- Participated in over 50 community events and met with organizations profiling MMVI, creating networks and initiating relationships to consider future partnerships on issues affecting indigenous women in Manitoba.
- Completed a Leadership Guidebook, currently working on implementation and promotion plan for delivery to Indigenous women's groups across the province.
- Received funding for Aboriginal Skills Employment and Training Strategy (ASETS) through Native Women's Association of Canada (NWAC) for 2015-2016 and again in 2016-2017.
- In 2015 2016 8 of 8 ASETS participants graduated from their program(s). Graduates were Indigenous Women from various regions of Manitoba including: 3 Northern, 1 Interlake; 3 Southern; 1 out of Province.
- In 2016 2017 funding included supports for: short term programs; required documentation; and childcare (focus being on removing barriers to employment). Currently, funding has been extended to 3 participants for longer term (up to one year) programs. The number of applications received far outweighs the amount funding available.


#### Institute for International Women's Rights at the University of Winnipeg Global College

The Institute for International Women's Rights at The University of Winnipeg Global College was established in 2009 to provide students and faculty with channels for dialogue and action to further international women's rights.

The founding director, Prof. Marilou McPhedran, has a focus on facilitation of student engagement with research and activities that support 'demystifying' global governance in human rights through individual research projects (in collaboration with other universities and NGO partners), field courses (including the biennial UN field course held Avery sedond year eg 2013,2015,2017etc.) - as well as facilitating internship and practicum opportunities with UN agencies and international NGOs to promote women's human rights in the international systems.

For example, students are trained in how to be a rapporteur for a UN related meeting so that attendance at UN events requires of students a higher level of engagement, with responsibility to provide support to NGO work in those venues. These opportunities are made available through long standing international relationships and financial support from members of the broader Winnipeg community, derived from the 'Local to Global' events hosted by the Institute for International Women's Rights - Manitoba - the independent sister organization based in the community.





#### **MATCH International**

MATCH International has been working for 40 years to match the needs of the most marginalized women and girls in the global south with Canadian resources. The MATCH International Women's Fund supports grass roots groups with projects that dismantle barriers, challenge perceptions, change systems and transform society for a more equal world. Our committee in Manitoba works to raise funds for the MATCH International Women's Fund, and to raise awareness about the response of the MATCH Fund to violence, injustice and poverty.

We are very grateful for the generous donation to the Women's Fund from the IIWR to support human rights for indigenous women and girls. Together we are making the world a better place for women and girls.

IIWR-MB held 7 Board Meetings and 2 Executive Committee Meetings in 2015
IIWR-MB held 6 Board and Event Planning meetings so far in 2016
and the really big news -

IIWR-MB is now an organization in Special Status with the Economic and Social Council of the United Nations!

#### **Mondetta Charity Foundateion (MCF)**

MONDETTA CHARITY FOUNDATION (MCF) is pleased to be an organizational member of IIWR. In the early 1970s, two families left East Africa. Settling in Winnipeg, members of these two families came together and founded Mondetta Clothing Company in 1986. Nearly 20 years later, Mondetta created a foundation to give back to Kenya and Uganda. MCF was formed in 2004 and acquired charitable status in 2006. In 2016 Mondetta acquired charitable status as well in the U.S.

Mondetta Charity Foundation (MCF) strives to reduce barriers to education for children in East Africa through local partnerships.

MCF works with Kamwokya Primary School, located in a sprawling urban slum in Kampala, Uganda. Since 2005, MCF has maintained a food program that provides a hot meal to the school's almost 2,000 students on a daily basis, and has served about 3 million meals to date. MCF also supports the New Life Home Trust Day Centre in Madogo, a small settlement located in northeastern Kenya. The Centre provides educational lessons and daily meals, and is a safe and welcoming space for the sixty children that attend. The Centre also offers a community outreach initiative for adults.

Through generous donations and a major bequest, MCF was able to contribute to the construction of a new three-storey class-room wing at the Kamwokya School reducing classroom sizes to a more reasonable size and creating space for more children to attend. One of these classrooms is now being converted into a new library.

MCF is also in the beginning stages of a water harvesting and filtration project that will collect and purify rainwater, reducing the cost of water for the school, as well as providing a source of clean water.

## Grands 'n' More Winnipeg

#### Working for the grandmothers and AIDS orphans of Africa

AFTA 2 (Art from the Attic) — Grands'n'More Winnipeg held its second Art from the Attic sale in September. This has become an annual event, given that over \$30,000 has been raised at each sale. Prairie Regional Gathering held in Winnipeg – September 24<sup>th</sup> & 25<sup>th</sup>, 2016 Grands 'n' More Winnipeg was the host group for the bi-annual Prairie Gathering this fall. The weekend was an opportunity for grandmother groups from across Manitoba and Saskatchewan to "Remember – Reflect – Revitalize" about the 10 years of the Grandmothers to Grandmothers campaign of the Stephen Lewis Foundation. The gathering featured a sharing of member's experiences of the South African trip to the International AIDS conference in July 2016 as well as themed networking table groups where grandmother group members shared ideas for awareness and fundraising. A highpoint of the Gathering was Saturday evening's "Conversation with Stephen Lewis and Ilana Landsberg-Lewis" who not only shared the stage as part of a cross-Canada tour but delivered a retrospective of the 10 year grandmothers campaign and the current state of the AIDS pandemic. Sunday featured "Listening to the voices of the African Grandmothers" where 5 community leaders from the funded projects of the Stephen Lewis Foundation shared experiences about their grassroots organizations. The gathering closed with the Stephen Lewis Foundation staff leading workshops on "Impact and Resilience" as well as how to "Express Solidarity" with the African grandmothers and their orphaned grandchildren. Grandmothers and grandothers left inspired by solidarity with the African organizations and the Stephen Lewis Foundation.



**CUPE National and CUPE Manitoba** continue to support the Institute of International Women's Rights in Manitoba. The following is a snapshot of some of the involvement CUPE has had within the last year. In 2016, CUPE celebrated the 100 year anniversary of the Women's Right to Vote, sent a delegation to speak at the UN session on the Status of Women, and compiled and published bargaining guidelines to help our locals bargain equality into our collective agreements for members.

We continue to focus on fighting for pay equity both provincially and nationally, to advocate for and support groups working on the crisis of missing and murdered indigenous women, and facilitate workshops on domestic violence in the workplace as a health and safety issue.

CUPE supports the María Elena Cuadra Movement (MEC) in Nicaragua and Central America who seek to improve the ability of workers to defend their human and labour rights from a gender perspective. CUPE representatives attended the World Social Forum (WSF) which is one of the largest global gatherings of civil society. The Forum brings together tens of thousands of activists with the intention of identifying solutions to the most important issues of our time affecting the economy, the environment, human and trade union rights, and democracy. Thirteen themes came out of the Forum. One of these themes is Struggles against Racism, Xenophobia, Patriarchy and Fundamentalism.



2015-16 has been a busy year for the Council of Women of Winnipeg albeit our Council is small the Council has been able to accomplish some rather large goals and events. The first undertaking for CWW was a partnership with PCWM to organize a Federal Election Candidates debate with the focused discussion of key issues affecting women, families and communities. Expert women panelists presented key issues that were not been adequately addressed in the Federal campaign; Murdered and missing women and girls, Gender wage gap women, Women in leadership roles and Immigrant and refugee policies.

The forum was well attended by candidates and room was at capacity. The forum received national and local media coverage - a very successful event indeed.

After the election forum we had the wonderful opportunity to have Lore Mirwaldt QC as our program guest speaker addressing the issues of Family Law Basics for 2016 covering both provincial and federal legislation including spousal support advisory guidelines, custody, pensions, family property, divorce and separation. The National Council of Women of Canada (NCWC) and Council of Women of Winnipeg (CWW) were honoured to participate in the presentation "Lessons From the Heart" Indigenous Women Bringing Our Children Home at the sixtieth session of the Commission on the Status of Women (CSW60) at the United Nations Headquarters in New York March 23, 2016, New York, NY. The presenters were Sarah Gazan & Jackie Walker from Nisichawayasihk Cree Nation Family and Community Wellness Centre Inc., Margaret MacKinnon from Ma Mawi Wi Chi Itata Centre, Lore M. Mirwaldt from Mirwaldt, Gray, Poudrier Law, Cora Morgan from Assembly of Manitoba Chiefs. Moderated by Kelly-Ann Stevenson 1st Vice President National Council of Women of Canada and President Council of Women of Winnipeg. Manitoba leads the Western World in the removal of Indigenous children from their families. Lessons From the Heart; Indigenous Women are leading the way by challenging existing systems using Indigenous knowledge, laws, traditions and belief systems to create positive change. Note: IIWR-MB organized a report back to the community by the Manitoba delegation to the 60th meeting of the CSW at Ma MaWii in June.

PCWM agreed to partner with CWW in a spring fundraising event – High Tea with Nellie McClung April 24, 2016 at Dalnavert Museum and it was a profitable and enjoyable afternoon. CWW agreed to support and assist our Federate – Woman Healing for Change Inc. In their fundraising endeavours for Little Stars PLAYhouse (formerly known as the Phoenix Sinclair Playhouse) For the past seven years, they have been running a program called North End Stay and Play, the objective of which is to provide children and their families a place to play together, and together to learn the benefits that play provides. NESP has been running on a modest budget and has only been able to operate one afternoon a week, usually out of a donated church basement, but they have a dream they are working very hard to fulfill – a new, custom-built play house on Selkirk Avenue that will operate five or six days a week. It will be called the Little Stars Playhouse. CWW & Women Healing for Change's first shared fundraising event is the Margaret' Choir Benefit choir on May 6, 2016.

CWW's AGM was held on May 5th and the focus of our AGM was approval of the newly revised CWW By-laws and Standing Rules. Currently we are planning our fall / winter 2016/17 program starting with the development of two working groups Murdered and Missing Indigenous Women and Girls and Railroad Relocation and Safety for Winnipeg. Feedback from these groups will help us to develop resolutions for National Council of Women of Canada AGM June 2017 Ottawa, Ontario

## Winnipeg Safe City: Update Prepared for Institute for International Women's Rights Annual Report (October 2016)

In 2013 Winnipeg became the first North American city to sign onto UN Women's Safe Cities and Safe Public Spaces Initiative. The global initiative seeks to end sexual violence against women and girls in public spaces. Immediately after signing onto the initiative, the City of Winnipeg and Manitoba Status of Women worked to bring together organizations, agencies and government representatives who shared the commitment to work towards ending sexual violence against women and girls in Winnipeg. The Institute for International Women's Rights – Manitoba has been a committed partner and member of the Winnipeg Safe City steering committee from the very beginning.

This past September, the Winnipeg Safe City reported on progress achieved to-date and announced a number of current/new initiatives, including:

- The release of a comprehensive report ("Scoping Study") examining the prevalence and experiences of sexual violence in Winnipeg. This report includes data sets from a number of quantitative and qualitative sources, including from focus groups held with over 150 Indigenous and newcomer women living in Winnipeg.
- The release of the Winnipeg Safe City website (winnipeg.ca/UNWpgSafeCity) and twitter account (@WpgSafeCity) which will be maintained by the City of Winnipeg.
- The release of Taxicab Passenger Safety brochures, available in six languages: English, French, Cree, Ojibwe, Tagalog and Arabic. These brochures were developed by the Southern Chiefs' Organization and were translated by the Province of Manitoba
- The re-release of Winnipeg Transit's Request Stop Program, a program which allows passengers to request to be let off between regular stops after 7 pm.
- Program update from Heart Medicine Lodge at Ka Ni Kanichihk. Heart Medicine Lodge is Canada's first Indigenous-led healing program for survivors of sexual violence and trauma. The program runs in 12-week sessions and is currently in its second round. Program participants are provided with the opportunity to experience a cedar bath ceremony, pipe ceremony, sweat lodge lodge and full moon ceremony as part of their healing journey.
