MANITOBA DELEGATION TO PRESENT AT THE UNITED NATIONS

COMMISSION ON THE STATUS OF WOMEN

March 1, 2019

Winnipeg, MB (Treaty Territory One) – In preparation for International Women's Day (March 8th), the Institute for International Women's Rights Manitoba (IIWR-MB) delegation announced that it will be hosting a parallel event during the sixty-third session of the Commission on the Status of Women (<u>CSW63</u>) at the United Nations. The delegation's event titled **"YOUTH SPEAK OUT: Canada's Social Protection Systems"** will take place on March 12th and will focus on the session's priority theme: Social protection systems, access to public services and sustainable infrastructure for gender equality and the empowerment of women and girls.

In July 2016, the IIWR-MB received Special Consultative Status with the Economic and Social Council of the United Nations, making it the first and only non-profit organization in Manitoba to have such a designation. It is with this special status from the United Nations, that the IIWR-MB is able to send a delegation to the CSW63 and host it's third official parallel event.

The IIWR-MB delegation is comprised of a number of Manitoba and Ontario based organizations who support the rights of Indigenous Youth and communities. There will also be youth representation from the refugee community. A short video, capturing the diversity of youth, will be shown. In keeping with the group's interests, their event aims to educate the global community and Canadian Government representatives about the challenges Youth face in Canada's protection systems but also share the resilience of Youth and share solutions to address challenges.

The delegation has also informed representatives of the Government of Canada and has invited them to attend the presentation. They will also be developing a report from the CSW63 that will be shared with the community and key government officials for further engagement and action.

The delegation acknowledges and thanks the team who have supported and coordinated the delegation. "All colonial government systems, particularly Social Protection Systems, have failed the women, girls and youth of the MKO First Nations. Manitoba is home to the highest rates of Indigenous child welfare apprehension, the highest rates of Indigenous youth incarceration, and the lowest Grade 12 graduation rates for Indigenous youth and girls in the entire country. These unacceptable outcomes, which have included MMIWG issues, are the legacy of colonialism and a symptom of the ongoing degradation of our inherent, Treaty, and title rights by both the provincial and federal governments. In solidarity with the delegation, MKO calls on the international community to support recognition of the rights of women, girls, and youth of MKO First Nations. International recognition of rights, and determined efforts on the domestic front, will assist with the root causes of the marginalization and disempowerment of the women, girls, and youth who are the foundation of our MKO Treaty Nations within the Canadian nation state. The State attempts at Indigenous eradication have not worked; and our northern Manitoba First Nations women, girls, and youth have remained resilient and, for the most part, remain connected to our lands, languages and cultures these attempts at eradication notwithstanding."
