

CO-CHAIRS REPORT

The Institute for International Women's Rights Manitoba was established in 2013, and is a non-profit organization founded to deliver public education and information-sharing among members and their respective networks to support educational, economic, social, and health opportunities for women and the LGBTQ+ community, locally and globally.

While this may have been a year filled with unprecedented times and setbacks, we have still managed to do much of the work we usually would, such as our **Local to Global** Fundraiser with guest speaker Tanya Talaga and emcee Sheila North. This year the monies raised went toward Ma Mawi Wi Chi Itata Centre, Artbeat Studio, and student bursaries for experiential learning for students registered with the Global College, University of Winnipeg.

Our 16 days of Activism Against Gender-Based Violence campaign is another successful example. We also started a campaign for a Feminist Response to COVID-19 in Manitoba, and gathered dozens of signatures for our open letter to the Manitoba Government detailing the necessity of a feminist approach to this pandemic.

Although the 64th session of the **United Nations Commission on the Status of Women (CSW64)** conference was cancelled in March 2020, the panel titled "Canada's unfinished business: Tomorrow's change makers Beijing +25" was able to present at a local initiative hosted by the IIWR-Mb Youth Council via zoom.

This year was our first year with a dedicated **communications chair and committee**. This committee has been a valuable addition to the IIWR-MB and you may have seen their work in our newsletters and on our social media platform.

This past year we welcomed our first ever **practicum student**, **Meara House**, from the department of Criminal Justice at the University of Winnipeg.

It really has been quite the year for us!

2020 was an unprecedented year in a multitude of ways, but it also sparked energy and initiative amongst our Advocacy Committee (AC). We developed partnerships, collaborations, held meetings with government officials, and developed an effective platform to engage and meet regularly as a committee. Despite global setbacks to the achievement of gender equity, the AC strove to build on our 2019 revision and renewal campaign in order to better connect with and support our communities within Manitoba, Canada and abroad.

In response to our 2019 review, the AC also developed new guidelines to reflect our ongoing work and efforts which focused on creating an active and engaged committee. We are also continuing to work on reviewing the language used by IIWR-MB to ensure a more inclusive approach to our work and advocacy. We have found that the new guidelines, along with monthly zoom meetings, have increased engagement and brought about renewed support for our advocacy and activism efforts. Leading to the creation of two major advocacy campaigns and increased capacity to respond to community needs.

The AC and board have encouraged and contributed to the endorsements, events, and campaigns for all of 2020. The work of our Advocacy Committee was notable in the Feminist Response to COVID-19 Campaign, which is ongoing, and our annual 16 Days of Activism Against Gender-Based Violence. We look forward to continuing our work to advance issues of gender equity and feminism that emphasizes intersectionality, collaboration, and inclusivity. With the continued dedication and drive from our committee, we look forward to continuing with our advocacy efforts on behalf of IIWR-MB into 2021.

The Year in Review

Since the 2019 Annual General Meeting, the Committee has participated in the following advocacy initiatives on behalf of the IIWR-MB:

Endorsements / Initiatives

- ❖ Endorsed Advocating for a Strong Gender Lens on the COVID-19 Pandemic open letter calling on Prime Minister Trudeau to develop a Federal Feminist Response to COVID-19.
- ❖ Endorsed the letter by feminist organizations across Canada to Prime Minister Trudeau and relevant ministers calling for feminist policy making in the context of COVID-19.
- Signed-on to the open letter Civil Society Recommendations for the Functioning of the Action Coalitions. Calling on the NGO CSW Civil Society Action Coalitions to expand their work in terms of accessibility, inclusivity, collaboration, and open communication. - ❖ Endorsed Communities not Cuts Suppress the Virus Manitoba Petition, and encouraged individual sign-ons. The AC supports their ongoing work.
- ❖ Joined Make Poverty History Manitoba as a coalition member and support their ongoing work.
- Endorsed Migrants Rights Network: Status for All campaign and ongoing efforts.

Events

- ❖ IIWR-MB AC members attended a number of community demonstrations, protests and events representing IIWR-MB. We have chosen to highlight a few we were more directly involved with.
- ❖ Senator Marilou McPhedran's Youth Forum (in lieu of the UN Commission on the Status of Women). In light of the cancellation of CSW, Senator Marilou McPhedran hosted a Youth Forum to encourage youth activism and dialogue. Taking place at the Senate of Canada on March 10th & 11th, 2020, multiple members of the AC participated in the forum.
- **Canada's Unfinished Business: Tomorrow's Change Makers (rescheduled CSW panel).** Micaela was a panelist representing the AC to discuss the need for a feminist response to COVID-19. The panel was scheduled as a make-up to IIWR-Mb's parallel event initially scheduled for CSW. The event took place Friday, September 18th.

❖ Community Consultation-Together Against Inequality: GBA+ and a Feminist Response to COVID-19 in Manitoba. The AC hosted this event as part of an ongoing dialogue sparked from the Feminist Response to COVID-19 campaign about the need for a Gender-Based Analysis+ platform in Manitoba. The event was held via zoom and engaged community members about the unique needs Manitobans have and how they should be reflected in a GBA+ platform.

Campaigns

1) Call for a Feminist Response to COVID-19 in Manitoba

In response to the emergent needs of our communities in wake of the COVID-19 Pandemic and consequential shutdown of many parts of the world, resulting in a direct impact of women, girls and 2LGBTQIA+ folxs, the AC launched our call for a Feminist Response to COVID-19 in Manitoba. The campaign garnered attention to the unique needs facing women, girls and 2LGBTQIA+ folxs in Manitoba and involved the following actions and initiatives:

- Our Manitoba campaign calling for a feminist response to COVID-19 through our open letter sent to government officials on May 25th, 2020. The letter was endorsed by over 100 individuals and 18 organizations.
- An ongoing letter writing campaign launched May 27th, 2020 with a subsequent op-ed written by Leah and published by CBC on May 31st.
- Meetings with government officials on the need to implement a Feminist Response to COVID-19 to discuss a more equitable and just recovery.
- A social media campaign posting regularly to promote national and international campaigns calling for feminist response to COVID-19 around the world.
- An updated resource list located on our advocacy website with campaigns, initiatives and actions from around the globe for visitors to support and share.
- The above mentioned community consultation in preparation of the submission of a private members bill to implement a GBA+ within Manitoba.

2) 16 Days of Activism Against Gender Based Violence

The Advocacy Committee successfully ran IIWR-MB's Annual 16 Days of Activism Against Gender-Based Violence from November 25 to December 10th, joining with organizations and individuals world-wide working to end gender-based violence in their local, national and international communities. Each day saw an action or event to engage with virtually/on social media.

- Members of the AC collaborated to create a video discussing what the #16Days of Activism means to them.
- Micaela wrote about the significance of the 16 Days of Activism Against Gender-Based Violence and the ongoing need for a feminist response to COVID-19 in Manitoba.
- Amplified SightSavers campaign calling for supporters to send an email to their countries' UN ambassador regarding the appointment of 9 positions to the UN disability committee to see the committee itself to have better representation from women, as well as people with different types of disability and people from lower income countries. The campaign resulted in the UN Committee on the Rights of Persons with Disabilities achieving gender parity for the first time ever, with 11 of the 18 seats being held by women.
- Amplified Canadian Women's Foundation call for individuals to sign and share a letter demanding that the government take the next steps towards a National Action Plan.

- IIWR-MB Advocacy Committee participated in the call for written submissions regarding Canada's proposed Feminist Foreign Policy. The written submission was sent to Global Affairs Canada can be found by going to: https://iiwrmb.ca/feminist-foreign-policy/. The video submission were published on our social media.
- Giving Tuesday aligned with World AIDS Day this year and we published an interview with Mike Payne, Executive Director at Nine Circles Community Health Centre, about the significance of World AIDS Day and the need for public health education.
- Amplified Canadian Labour Congress letter-writing campaign calling for the
 Canadian Government to help end sexual harassment and violence which drew
 from the 16 Days Campaigns three key demands to governments including to
 Ratify ILO Convention 190 and C189 on Violence and Harassment in the World of
 Work and to take steps to eliminate all forms of gender-based violence and
 discrimination in the world of work.
- Amplified the Migrants Rights Status for All campaign on social media.
- For International Day of Persons with Disabilities day we supported Barrier Free MB in their call for the province to create a plan to prevent ableism in the health system if it becomes overwhelmed due to Covid-19.
- Collaborated with Shameless Circle in a "takeover" from them of our social media to discuss cyber violence.
- Zachary Fortin wrote an article about understanding the intersections of Gender Based Violence and the LGBTQ2IA+ community in the #COVID19 Pandemic.
- For the Day of Remembrance and Action on Violence Against Women former Grand Chief Shelia North wrote an article about Missing and Murdered Indigenous Women, Girls and Two-Spirit.
- Community organizer, author and public speaker, Michael Redhead Champagne wrote an article about 6 Things Men and Boys Can Do to Stop Gender-Based Violence
- For Human Rights Day Leah wrote an article about the work of community in responding to the pandemic and why GBA+ is a first step to support our communities.

Our advocacy committee strives to be responsive and inclusive of all communities and voices in our work to ensure the rights of women, girls and gender-diverse folks in Manitoba. 2020 presented challenges but also opportunities to embrace advocacy efforts that emphasize justice, peace, joy, love and importantly, equality. We look forward to ongoing efforts in 2021 to further our mission, vision, and advocate for peace, justice and equality.

YOUTH REPORT

2020 marked the launch of the Youth Council for IIWR-MB with 12 members over its inaugural year. The Council is open to young members of IIWR-Mb between the ages of 16 and 30. It aims to provide a safe space for young people to engage in the human rights topics while fostering youth engagement in the wider institution.

In 2020 the Youth Council:

- Participated in the Youth Forum organized through the office of Senator Marilou McPhedran and the Canadian Council of Young Feminists from March 9th -10th, 2020 in Ottawa, Ontario.
- Hosted games nights aimed at providing fun activities and an opportunity for
 young people to socialize during the COVID-19 lockdown. Games included trivia
 and virtual Pictionary. It was encouraged that all participants make a small
 donation which the Youth Council gave to women's shelters in Winnipeg.
- Hosted the panel "Canada's Unfinished Business: Tomorrow's Change Makers on September 18th, 2020. This panel was originally organized for the 64th Session of the Commission on the Status of Women which was to take place in New York in March of 2020 but was cancelled due to the COVID-19 pandemic. Speakers included Winter Dawn Lipscombe (Treaty #3 Youth Executive), Teruni Walaliyadde (SEED Winnipeg), Sara Usman (Shameless Circle), Micaela Crighton (IIWR-Mb), and Renata Meconse (First Nations Health & Social Secretariat of Manitoba) as the moderator. The event included opening remarks from Sheila North (University College of the North).
- Launched a social media campaign to celebrate the 20th anniversary of UN Security Council Resolution 1325 on Women, Peace and Security from October 26th-31st. It included facts, resources and information on WPS both domestically and internationally.
- Hosted the panel 'Leaders Today: Young Women Speak Peace & Security in Manitoba' to celebrate the 5th anniversary of UN Security Council Resolution 2250 on Youth, Peace and Security. The event featured young individuals whose work has had an effect and influence in Manitoba. Speakers included Anne Campbell (formerly the Global Network of Women Peacebuilders), Winter Dawn Lipscombe (Treaty #3 Youth Executive Council), Sanjida Ahmed (IIWR-Mb), Kakeka Thundersky (Land Defender), and Shayne Wong (IIWR-Mb).

Local to Global 2020 All Our Relations: Finding the Path Forward With Tanya Talaga, and emcee Sheila North

Final Report: For a number of years, a small but energetic and committed group of women (and allies) have worked to put on a community event in Winnipeg called "Local to Global", focusing on different themes, but always through a gender lens. Initially as part of the Canadian Committee for UNIFEM, later as part of the Canadian Committee for UN Women, and now as the Institute for International Women's Rights - Manitoba (IIWR-MB), it has been an opportunity to bring the community together, to learn about the challenges women face in many parts of the world, including right here in Canada, and to raise funds for projects supporting gender equality and eliminating violence against women.

Initially planned for April 14, 2020, the Local to Global was held with much success on October 1, 2020. IIWR-MB was pleased to welcome guests to the 11th bi-annual Local to Global fundraiser as a webinar. Keynote speaker Tanya Talaga spoke about All Our Relations: Finding the Path Forward with emcee Sheila North. Musician Dawn Marie Chartrand also performed.
